Subject: Outcome of the meeting of the Board of RSWM Limited ("Company") held on January 13th, 2023. – Allotment of Equity Shares

Dear Madam / Sir,

This is further to the meeting of the Board of Directors of the Company held on 27.05.2022 and the meeting of the Rights Issue Committee of the Company held on 12.12.2022, approving the offer and issue of equity shares of the Company ("**Rights Equity Shares**") by way of a rights issue to eligible shareholders of the Company as on the record date for an amount aggregating up to \gtrless 23,550.84 lakhs in the ratio of 1:1 Rights Equity Shares i.e. One Equity Share for every One Equity Share held by the Eligible Equity Shareholders of the Company ("**Issue**") in accordance with the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended and other applicable laws on the record date i.e. 16th December, 2022 which opened for subscription on 23rd December, 2022 and closed on 06th January, 2023.

In relation to the aforesaid Rights Issue and pursuant to the finalization of the basis of allotment of the Rights Issue in consultation with the Lead Manager / Registrar to the Issue / Designated Stock Exchange i.e. BSE Limited, the Board, at its meeting held today, i.e., 13^{th} January, 2023 *inter alia*, considered and approved the allotment of 2,35,50,842 Rights Equity Shares at a price of ₹ 100/- per Rights Equity Share (including a premium of ₹ 90/- per Rights Equity Share) ("Allotment").

Accordingly, pursuant to the aforesaid Allotment, the paid-up equity share capital of the Company has increased to \gtrless 4710.1684 lakhs comprising of 4,71,01,684 equity shares of face value \gtrless 10/- each.

The above disclosure is made in terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. The meeting commenced at 11:00 A.M and concluded at 11:35 A.M.
