The results shall be declared within 2 working days i.e. Tuesday, March 25, 2025 by posting the same on the website of the Company (www.rswm.in), website of NSDL (www.evoting.nsdl.com.) and by filing with BSE Limited (www.bseindia.com) and National Stock Exchange of India Limited (www.nseindia.com) where the equity shares of the Company are listed. It shall also be displayed on the Notice Board at the Registered Office & Corporate Office of the Company.
